

Installation and Operating Instructions For: Double Dosatron Dispenser Panel

Mounting

 Select mounting location on wall at height where unit can be easily serviced and is located near water source. Hold board level, and mark spots on wall for each mounting hole on board. Use 5/16" bit to drill 1-1/2" deep holes in the wall. Hold board on wall and insert 1/4" x 1-7/8" sleeve anchors (provided) in drilled holes. Tighten anchor nuts.



Plumbing & Electrical

- 1. Loosely fit clamps on hoses. (C)
- 2. Run city pressure line to water inlet. 1



Do not exceed 85 PSI. Max. Operating temperature is 104° F (40° C)

- 3. If installing more than one system use clean water outlet from the first unit and run a hose to the water inlet of the second unit.
- Install chemical suction hoses to chemical inlet #1 & chemical inlet #2. (2)





- 5. Place strainer end of chemical suction hoses into chemical concentrate.
- 6. Run a 3/4" hose from metered outlets to desired locations, install clamps. (3)
- 7. Tighten all clamps.



Turn off power before installing or servicing system.

- 8. The double dispenser system does not come with its own power source & requires a 24V signal for proper operation.
- Wire from menu signal on terminal block in main control panel to solenoids. When solenoids are charged water will flow through metering system & then to bay. (4)
- 10. Check all electrical connections for proper fit before returning electrical service.



Operation

- Inspect system for proper plumbing & wiring. Make sure all clamps are tight in both equipment room & out in bay. Check hoses for kinks & abrasion hazards. Re-Route if necessary.
- 2. Turn on water supply, check for leaks.
- 3. Energize Solenoids.



Energizing solenoids requires power to equipment and can activate other systems. Take extreme caution when unit is powered and in standby mode.

4. Adjust chemicals.


5. After unit has been properly adjusted & tested it is ready for service.


